With reference to the notice of Symphony Communication Public Company Limited ("the Company") to the Stock Exchange of Thailand No. CS2563/004 dated August 11, 2020 regarding the entry into the Share Sale and Purchase Agreement of AIMS Data Centre (Thailand) Limited ("ADCTH") with Planet Tapir Sdn. Bhd. ("Planet"), the Company's connected persons, and the receipt of the transfer of 270,039 shares, representing 49 percent of the total shares of ADCTH from Planet on August 11, 2020, the Company would like to further advise that the Company completed the subscription of the 219,961 newly-issued ordinary shares of ADCTH on a pro rata basis, totaling Baht 21,996,100. Therefore, total shareholding in ADCTH is 490,000 shares, representing 49 percent of the total shares of ADCTH.

Moreover, the Company completed the novation of rights and obligations under the agreements in relation to 1) office space leasing and services at Smooth Life Tower for total three floors with a total area of 2,195.86 square meters, 2) the installation and the CFRP material purchasing and the structure reinforcement, and 3) the construction of data centre at Smooth Life Tower to ADCTH; and received the payment of Baht 159,951,812 (One hundred fifty nine million nine hundred fifty one thousand eight hundred and twelve Baht).

In this regard, all transactions as mentioned above were in accordance with the resolution of the 2020 Annual General Meeting of Shareholders, held on July 31, 2020, which approved the Company to enter into the joint investment in ADCTH to develop and operate the data centre business.
